# 15 Description of Equipment or Protective System

An MTL4032 Pulse Isolator is designed to restrict the transfer of energy from unspecified safe-area apparatus to one of four intrinsically safe circuits by the limitation of voltage and current. A transformer and two intrinsically safe opto-isolators provide galvanic isolation between the hazardous and non-hazardous area circuitry.

The apparatus isolates pulses from switch, proximity detectors, current pulse transmitters located in the hazardous area.

LED indication is provided to indicate power-on and the state of the output.

The apparatus comprises of a single isolating transformer, two I.S. opto-isolators, four detection circuits with zener-diode/diode/resistance combinations to provide voltage and current limitation. The above, together with other electronic components are mounted on a printed circuit board and housed in a moulded plastic enclosure. Polarised plugs and sockets are provided for the hazardous and non-hazardous connections.
