15 Description of Equipment or Protective System

The MTL5344 Two Channel Repeater Power Supply, 4/20mA for two wire transmitters is designed to provide a fully floating d.c. power supply for energising two conventional 2- wire 4/20mA transmitters which may be located in the hazardous area and to repeat the current in two floating circuits to drive two safe area loads. It restricts the transfer of energy from unspecified safe-area apparatus to an intrinsically safe circuit by the limitation of voltage and current. Four transformers provide galvanic isolation between the hazardous and non-hazardous area circuitry.

The apparatus comprises of two power transformers, two current transformers, and two output channels each protected by duplicated zener diodes chains on 2mm track and active current limiting components to provide voltage and current limitation. The above, together with other electronic components are mounted on a printed circuit board and housed in a moulded plastic enclosure. Polarised plugs and sockets are provided for the hazardous and non-hazardous area connections.
