Schedule

EQUIPMENT:

Equipment and systems covered by this certificate are as follows:

An MTL5049 Two Channel Isolating Driver, 4/20mA is designed to isolate and to pass on a 4/20mA signal from the safe area terminals, to the hazardous area terminals. It restricts the transfer of energy from unspecified safe-area apparatus to an intrinsically safe circuit by the limitation of voltage and current and provides galvanic isolation between the hazardous and non-hazardous area circuitry.

The apparatus comprises two power transformers, two current transformers, and two output channels each protected by duplicated zener diodes chains and current limiting resistors to provide voltage and current limitation. The above, together with other electronic components are mounted on a printed circuit board and housed in a moulded plastic enclosure. Polarised plugs and sockets are provided for the hazardous and nonhazardous connections.

An MTL5045 Isolating Driver, 4/20mA is similar to the MTL5049 but has only components suitable for one channel fitted to the common PCB.
