#### 13 DESCRIPTION OF EQUIPMENT

The Barracuda 19" WS Gen 2 workstation is a stand-alone Human Machine Interface (HMI) designed for use in industrial conditions. It can be utilized in rig floor applications such as MWD / LWD, mudlogging, or well stimulation in oil and gas operations where a display or workstation must be able to withstand shock and vibration. The Barracuda 19" Gen 2 is a computer with a built-in touch screen display housed in an aluminium environmental enclosure rated to IP66. The front panel includes additional controls for power, brightness, and touch screen operation. Power and I/O communications are provided through military-style connectors. There is an option to run the unit on either AC or DC power. There is also an option for an extended operational range with the inclusion of on-board heaters.

**Variation 1** - This variation introduced the following change:

- i. The original external USB, a KENSINGTON BLUETOOTH 2.1 USB MICRO ADAPTER Model K33902US, is being replaced with a KENSINGTON BLUETOOTH 4.0 USB MICRO ADAPTER Model K33956AM made by the same manufacturer.
