The Manufacturer shall note the following conditions of manufacture:

- The values of resistors RA, RB, RC, RD, RE, RF, RG, RH, RJ, RK, RL and RM shall be chosen such that the crowbar triggering voltage of each of the two crowbar circuits associated with IC6 and IC7 occurs at a voltage less than, or equal to, 12.4 V. Each of the two crowbar circuits shall be subjected to routine tests to establish that the requirement above has been met.
- Each of the two active current switch-off circuits associated with IC4 and IC5 shall be subjected to
 routine tests to establish that current switch-off (i.e. circuit switching state) occurs at a load current
 less than, or equal to, 505 mA.
- The following routine test shall be carried out on transformers TX1 and TX2 (TRF305). As required by clause 11.2 of EN 60079-11:2007, a voltage of 1500 Vrms shall be applied for 60 seconds between:
 - the primary and secondary (1) windings
 - the primary and secondary (2) windings
 - the secondary (1) and secondary (2) windings
